- 4. File SUP22-04-10 requesting a Special Use Permit for a Recreational Camp/Farm Retreat on a property zoned Agricultural Residential for property at 0 Biddy Road; Floyd County Tax Parcel N15008. The planning staff recommended approval. The planning commission voted 7-0 to approve.

 - 1. Consider request from the Clerk of Superior Court to approve an increase to the per diem rate for the Board of Equalization.
 - 2. Consider request from the County Clerk to approve the transfer of ownership for the Mapco Express, Inc., located at 2930 Martha Berry Highway to Avion Properties, LLC.

- 3. Consider purchase of a FATS-100P System & Firearms Weapon Simulators Training System for the Floyd County Police Department in the amount of \$85,000.00. This was budgeted through a training grant acquired from the Criminal Justice Coordinating Council in the amount of \$85,000.00.
- 4. Consider request from Purchasing to approve additional funds in the amount of \$9,840.00 from an AC unit for the Floyd County Prison, ordered in 2021, that was not delivered until 2022. This was budgeted at \$9,900.00 in the 2021 Prison equipment budget.
- Consider recommendation from Human Resources to amend the Floyd County Compensation and Pay plan by regrading the Office Manager III position located at the Floyd County Prison which is a paygrade 13 to an Office Manager V job classification which is a paygrade 16. No budget amendment is required for 2022.
- 6. Consider request from Purchasing to approve the purchase of two (2) Side Dump Trailers for the Rome Floyd Recycle Center in the amount of \$17,580.00 (\$35,160.00 total) from Pro-Trainer. This was budgeted in the FY2022 capital budget.

Consider request from the Police Department for the adoption of a contract between RedSpeed, Inc., and Floyd County for the operation of photographic speed detection in the Armuchee Elementary School Zone on U.S. 27/GA 1 (Martha Berry Highway). This has been unanimously approved by the Floyd County Board of Education. Mr. McCord presented the item to the Commission for approval. Commissioner Wallace made a motion to approve, seconded by Vice Chair Watters.

- 3. Consider request from Purchasing to approve the purchase of fifteen (15) Mobile Vision In-Car Camera Systems and fifteen (15) Mobile Vision Body Worn Cameras in the amount of \$135,925.00. This was budgeted in the 2017 SPLOST. Mr. McCord presented the item to the Commission for approval. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. The motion carried 5-0.
- 4. Consider request from the Floyd County Prison to approve a new Georgia Power service connection in the amount of \$7,260.00 to the Floyd County firing range. This was budgeted in the 2017 SPLOST Mr. McCord presented the item to the Commission for approval. Vice Chair Watters made a motion to approve, seconded by Commissioner Wallace. The motion carried 5-0.
- 5. Consider request from Purchasing to approve the purchase of a John Deere 6105E 2 WD with a canopy and a Tiger TSR60EDH mower in the amount of \$103,895.00 from Ag-Pro for Public Works. This was budgeted at \$100,000.00, therefore the overage in the amount of \$3,895.00 will from the savings of the Ford F-750XL w/Grapple Knuckle Boom and Bed that was under budget. Mr. McCord presented the item to the Commission for approval. Commissioner Maxey made a motion to approve, seconded by Commissioner Wallace. The motion carried 5-0.
- 6. Consider request from Purchasing to approve the purchase of one (1)
 Hydraulic Excavator in the amount of \$162,035.00 from Sany America, Inc.
 for Public Works. This was budgeted in the 2017 SPLOST at \$275,000.00. —
